**Sub:- Financial Assistance to Gram Panchayats for improved sanitation for the month of June, July & August 2019-20.**

The Governor of Haryana is pleased to accord the sanction for payment of Rs. 35,13,84,000/- (Rs. Thirty Five Crore Thirteen Lac Eighty Four Thousand only) at the disposal of Budget Controlling Officers as Financial Assistance to Gram Panchayats for Improved Sanitation in the villages, for further allotment to the Block Development & Panchayat Officers. The BDPO's will transfer the funds to the concerned Sweepers in their bank account through R.T.G.S. after completing all formalities in compliance of direction issued vide this department letter no. 94446 dated. 18.10.2018 & other instructions issued from time to time. The funds available under this scheme may be used for payment of remuneration to the sweepers @ Rs.11,000/-P.M. It may be ensured that the Number of Sweepers does not exceed the norms fixed by this office vide letter No. 1214/TSC- MEC-V/ 2007/3046 dated 7-9-07. The District-wise allocation is as under:-

1. It being a Honorarium, no DDO Authority is required to be issued, as per Haryana Govt. Notification No. 2525/2 FR-2-76/40108, dated 12-12-1976.
2. The amount mentioned against each District may be further allocated to the Blocks for credit in the bank accounts of **concerned Sweepers through R.T.G.S. after completing all formalities at due time (within 7 days).**
3. The expenditure may be booked to the **Major Head P-01-32-2515-51-789-96-87- Honorarium Financial Assistance to Gram Panchayats for improved sanitation (SCSP) component (Plan Scheme).**
4. The expenditure report for compilation of figures of all blocks must be sent to the Director General, Development & Panchayat Deptt., Haryana through Deputy Commissioner by the 10<sup>th</sup> of every month for review.
5. They are also directed that further allotment of budget **at Block Level** should be released only upto sanction strength. (Actual workers.)
