Sub:- Release of funds for uniforms and one pair of shoes to the sweepers under the Scheme for the employment Generation Programme for Scheduled castes.

The Governor of Haryana is pleased to accord the sanction for payment of Rs. 3,72,68,000/- (Rs. Three Crore Seventy Two lac Sixty Eight Thousand only) at the disposal of Budget Controlling Officers as Financial Assistance to Gram Panchayats for Improved Sanitation in the villages, for further allotment to the Block Development & Panchayat Officers. These funds may be used for providing khaki uniforms Rs. 3,500/- per annum. It is mentioned that the uniforms and shoes are to be provided and the money should be paid in cash to each sweeper for the purpose. The District-wise allocation is as under:-

2- The amount mentioned against each District may be further allocated to blocks for credit to account of Gram Panchayats at due time of payment for disbursement of remuneration to the sweepers.

- 3- The expenditure may be booked to the Major Head P-01-32-2515-51-789-96-87-**Honorarium Financial Assistance to Gram Panchayats for improved sanitation (SCSP) component (Plan Scheme).**
- 4- As already mentioned in this office Memo no. 1214/TSC/MEC-V-2007/3046, dt.7.9.2007, the amount is to be transferred to the concerned Panchayats within 7 days of receipts. Therefore, You are directed to draw the above said amount and transfer to the concerned Gram Panchayats for the above said purpose. The Panchayats may also be directed to keep a separate account for this purpose.
- 5- The Panchayats should be advised to provide Khaki uniforms and black shoes to those sweepes, who had worked for atleast 6 months and are likely to continue in future.
- 6- A report to the effect that the uniforms and shoes have been provided to the sweepers, may be sent to Head office 30.6.2019.
- 7- They are also directed that further allotment of budget **at Block Level** should be released only upto sanction strength. (Actual workers.)
