

ORDER

The Governor of Haryana is pleased to accord approval for the release of funds amounting to ₹ 2,38,60,000/- (₹ Two Crore Thirty Eight Lac & Sixty Thousand only) during the financial year 2019-2020 for the payment of annuity to the Gram Panchayats @10,000/- per acre, per year whose land has been utilized for allotment of plots to the families of Scheduled Castes, Backward Class(A) and BPL families under Mahatma Gandhi Grameen Basti Yojana.
