- The Gram Panchayats is advised to execute the work strictly in accordance with the guidelines issued by the Government from time to time.
- 7. The GP, by majority shall pass resolution for issuing administrative approval of works.
- Before start of execution of work proper estimates of the works be frame and technical approval be granted by the competent authority.
