In continuation to the earlier issued sanction vide letter No. 67099-13 dated 04.09.2019, 1660 dated 25.05.2023 and 3016 dated 31.08.2023, the Governor of Haryana is pleased to accord already sanctioned within estimated cost of Rs. 2,82,44,000/- (Rs. Two Crore Eighty Two lakh Forty Four Thousand only) and to release an amount of Rs. 2,82,44,000/- (Rs. Two Crore Eighty Two lakh Forty Four Thousand only) for various development works in the given below villages of District Bhiwani under the Scheme, Haryana Gramin Vikas Yojna for the year 2025-26, with the following conditions:-

1. The District Administration/Executing Agency shall ensure before start of work that proposed works/projects has not been got sanctioned/executed earlier from any other scheme and is covered under the guidelines/instructions issued by the State Government from time to time in the HGVY.
2. The amount shall only be utilized for the purpose for which it was sanctioned otherwise fund be refunded to Head Quarter.
3. The work shall only be executed on Revenue/public land/Rasta/Street which have been earmarked and ownership falls in the name of Gram Panchayats concerned.
4. Executive Engineer concerned shall ensure that monthly progress report of these works is sent to Chief Engineer by fifth of each month. The quality of work shall be maintained.
5. The amount under SCSP component should be utilized only for the benefit of Scheduled Castes population.
6. The Executing Agency shall ensure that all relevant rules/instructions/procedure are followed strictly. In case of any change in the proposed items of work, the same should be got sanctioned from competent authority before taking the work in hand.
7. The work shall be executed strictly as per P.W.D. specifications 1988, and as per latest amendments issued by Govt. from time to time.
8. Govt. of India has issued "Harmonized Guidelines and Space standards for Barrier free built Environment for persons with Disability and Elderly Persons & Feb-2016", which have already been sent to all concerned vide memo no. 9933-9944 dated 27.11.2019 (copy of Guidelines is also available at disabilityaffairs.gov.in). Executive Engineer, Panchayati Raj) shall ensure strict compliance of above-mentioned Provisions as per RPWD Act, 2016 and Central Rules formulated under the act and provisions be made in the Agreement accordingly.
9. Deputy Commissioner, Additional Deputy Commissioner, Chief Executive Officer (Zila Parishad)& Chief Engineer (PR) will be supervising and Monitoring Authority of development works, and after works are completed, the UCs must be submitted to Government with duly signed by CEO(ZP) with colored photo of the work executed so that UCs could be sent to PAG, Haryana. The labor Regulations with latest amendments, shall be strictly complied with by the Executing Agency at any cost.
10. Execution of work be started only after ensuring that the building/community center Chaupal/nala/rasta/streets are unconstructed or declared condemned and not use worthy otherwise funds be refunded back to sanctioning Authority
11. That the work shall be executed as per Haryana Panchayati Raj Finance, Budget, Accounts, Audit, Taxation and works Rules and instructions issued by Govt. from time to time.
12. That the executing Agency would start work as early as possible by following duly approved procedure as per rules and ensure timely completion of the work.
13. The Gram Panchayat, by majority shall pass resolution for execution of works.
14. The grant is further released with the condition that if any sewerage work is to be started or is already ongoing within the current financial year, then the works shall be taken up afterwards.
15. If any amount remains unspent after executing/completion of the work, the unspent amount alongwith interest earned, if any, will be refunded to HQ or shall be deposited in receipt head.
16. Before start of work, detailed estimate should be got sanctioned from the competent authority.

The expenditure involved will be debited under "Major head code P-01-20-4515-51-101-97-51-N-V-Haryana Gramin Vikas Yojana" (HGVY) for the year 2025-26.




