Subject:- Allocation of funds under Matching Grant Scheme for construction of Gau Shala, Main Gate, Computer Lab, Bhojnalya, Sulabh Shochalya and Repair of Building at Vidya Mahasabha Kanya Gurukul, Gram Panchayat Kharkhoda, Block Kharkhoda, District Sonipat.

The Governor of Haryana is pleased to accord approval of the sanction of Rs.96,00,000/- (Ninety Six Lakh Rupees only) (Rs. 32,00,000/- public share and Rs. 64,00,000/- Govt. share) to meet the expenditure for construction of Gau Shala, Main Gate, Computer Lab, Bhojnalya, Sulabh Shochalya and Repair of Building at Vidya Mahasabha Kanya Gurukul, Gram Panchayat Kharkhoda, Block Kharkhoda, District Sonipat under the Matching Grant Scheme during financial year i.e. 2025-26.

2. Accordingly, the amount of Rs.96,00,000/- (Ninety Six Lakh Rupees only) is being allocated under the above said scheme for construction of Gau Shala, Main Gate, Computer Lab, Bhojnalya, Sulabh Shochalya and Repair of Building at Vidya Mahasabha Kanya Gurukul in Gram Panchayat Kharkhoda, Block Kharkhoda, District Sonipat.

3. The expenditure amount of Rs.96,00,000/- (Ninety Six Lakh Rupees only) shall be debited under the budget head P-01-20-2515-51-101-93-51-N-V- Matching Grant-in-aid for Development works (Government Share) for the year 2025-26.

4. The provision made in the Haryana Matching Grants for Development Works Rules, 2024 dated 28th February 2024, and the instructions issued by the Government from time to time in this regard should be strictly adhered to. It is further directed that in execution of above said development works, the Deputy Commissioner, Sonipat will be responsible for the proper execution of the works and to ensure maintenance of accounts and submission of utilization certificate etc. and work shall be strictly executed by the agencies as prescribed in the Haryana Matching Grant for Development Works Rules, 2024 dated 28th February 2024.
